Ear tags for identification of bovine animal - 200,000 sets.

- 1.2.1. Each set should consist of a pair of laser-printed (marked) ear tags with the same identification number for both ears of an animal;
- 1.2.2. For each ear the tag shall consist of yellow interlocking male and female parts with the same identification number;
- 1.2.3. Shall be elastic, made of thermoplastic polyurethane material that may contain non-corrosive metal inserts or tips. Shall be used for single use and be resistant against high and low temperatures;
- 1.2.4. Information contained therein should be legible during lifetime of the bovine animal;
- 1.2.5. Shall not cause pain and allergic reactions after being inserted;
- 1.2.6. Shall include the manufacturer's mark and date of production;
- 1.2.7. The length of each part should be no less than 45 mm and the width no less than 55 mm;
- 1.2.8. Shall not have age limitation for the identification of the bovine animal.
- 1.2.9. Once sealed, the distance between male and female parts shall be not less than 7 mm;

Marking:

- 1.2.10. Both parts of the ear tag shall have laser-printed information;
- 1.2.11. Both parts of the ear tag shall indicate the country code with 2 letters "GE" and the animal's 8-digit identification numeric information according to the marking structure specified in annex #1;
- 1.2.12. The female part shall also include a barcode (code 128) on the outside surface;
- 1.2.13. The barcode shall fully include the identification number, both letters and digits, for instance, GE and 8-digit identification number;
- 1.2.14. Latin letters of the country code, barcode and identification number shall be placed in lines according to annex #1;
- 1.2.15. The ear tags shall be marked with the following non-repeatable, growing, sequence numbers:

GE 135 12001 to GE 137 12000;

- 1.2.16. The printed character and numeric information shall remain legible after being rubbed by hand for 15 s with a piece of cloth soaked with water and again for 15 s with a piece of cloth soaked in petroleum spirit (chemical solvent for the removal of alkyd enamels and spots);
- 1.2.17. Data on both tags must be matching and must be printed indelibly on the outside surfaces of both the male and female parts of the tag in black;
- 1.2.18. Must be easily read in field conditions and remain legible during the lifetime of the bovine animal.

Minimum dimensions of marking:

1.2.19. The marking structure is given in annex #1:

- 1.2.20. The female part should be marked in three lines: the first line not less than 8 mm, the second line (bar code) no less than 8 mm, the third line not less than 18 mm;
- 1.2.21. The male part should be marked in 2 lines: the first line not less than 8 mm, the second line not less than 18 mm;
- 1.2.22. Both parts of the ear tag shall also be marked with the logo of the National Food Agency (Annex #2).

Quality and Warranty:

- 1.2.23. The manufacturer must be certified with ISO 9001 standard.
- 1.2.24. The ear tags shall be consistent with EU requirements (Annex #3), which should be confirmed with relevant document issued by the competent authority of at least one EU Member Country, clearly clarifying that this model of ear tag is used for official bovine animal identification purposes in at least one EU Member Country.

 Or/And,

The ear tags should be certified by a certificate issued by the International Committee of Animal Recording (ICAR), which confirms that the ear tag model is approved for identification of bovine animal. The data should be posted on the ICAR's official website: http://www.icar.org/ and a copy of the certificate should be included in tender;

- 1.2.25. The goods presented as sample and the delivered product shall comply with each other and the tender documentation, for which the purchaser reserves the right to verify the goods presented as samples, as well as the purchased product in the appropriate laboratory; 1.2.26. The manufacturer must issue a warranty undertaking not to manufacture ear tags with the same marking for any other client. The supplier is obliged to provide a written guarantee letter;
- 1.2.27. The supplier must inform of **any** alteration or modification, however minor, to the approved designs compared to the ear tag approved in the EU Member Country, or/and certified by ICAR.

Loss Rate:

1.2.28. Loss rate of ear tags should not exceed 7%. The supplier should provide documentation confirming the annual loss rate, for tags in current use in EU Member States or other countries. Applicants not approved by EU Member Country Competent Authorities should provide certified field trial results. The methodology for the calculations and the raw data on which the calculations were based must be provided as tag loss rates must be verified by an internationally recognized body such as a competent authority, a research institution, ICAR or a standards accreditation agency. The calculation must be based upon a statistically robust sample of such a population, with a 95% confidence level in accordance with internationally recognized standards.

Welfare:

1.2.29. The Agency reserves the right to conduct field testing (Annex #4) of each batch of tags. If complications caused by the identification (edema, inflammation process, obstruction, tissue necrosis etc.) exceed the permissible limit (7%) specified paragraph 1.2.28, the Agency is authorized to conduct further research in appropriate laboratory to determine the compliance with the relevant conditions. If the ear tags, based on the results of the laboratory survey, do not comply with the required conditions, the supplier is obliged to eliminate the

inconsistency by replacing the full number of ear tags (already used and unused). In such case, the supplier is also obliged to reimburse the cost of laboratory research;

Applicator:

- 1.2.30. Ear tags should be accompanied with an appropriate applicators of the ear tags (ear tag marking device) no less than 300 pieces, with spare metal tips;
- 1.2.31. Applicator should be made of lightweight, non-corrosive material;
- 1.2.32. The applicator must have two "lips", one of which should be equipped with a fitting spring to fit the female ear tag, and the other shall be equipped with a tip to fit the male part of the ear tag;
- 1.2.33. A single-action applicator, whereby the ear tag itself pierces the ear. The applicator should not utilize double penetration or "dagger" type techniques.
- 1.2.34. The design and use of applicators should minimize the risk of pain and distress to the animal, safeguard the animal and operator from danger and guard against the spread of disease and risk of infection. Antibacterial coatings may be incorporated into the applicator to reduce the risk of infection;
- 1.2.35. Applicators should be designed so as not to allow incomplete union, lateral misalignment or oblique sealing of the male and female parts of the identification ear tag;
- 1.2.36. Applicators should be clearly marked with the tag manufacturer's name and the packaging or instructions should indicate the tags with which they can be used;

- 1.5.4. Package boxes should include information about the number/number range of the packed ear tags on at least two sides.

- 1.5.6. Transportation to the warehouse and storage of goods is obligation of the supplier.
