1.4 Term for goods/service delivery and fulfilment of work

1.4.1 Schedule and terms for delivery of procurement subject:

- Supply of the first lot of goods 200 000 items shall be carried out within 120 (One hundred and twenty) calendar days from the day of execution of the contract;
- The rest part of the goods shall be delivered in stages, under the following conditions: Supply of 400 000 400 000 during 2019 2020 years in each 3 (three) months (quarter) a year from the date of the first supply; while the final lot of goods to be supplied shall be determined by 300 00 items.

Note:

1. Each lot of the supplied number plates shall contain the quantity of the thermal transformer plates (per 2 500 000 items of number plates, 3000 items thermal transfer plates in total), which ensures the full and complete thermal processing of the number plates in the supplied lot; the presumable number of 3000 items of the thermal transfer plates according to the colors shall be as follows: black - 2950 items; red - 35 items; white - 15 items.

2. Before supply of each lot the supplier shall agree with the buyer the types and quantity of the number plates and thermal transformers within the scopes of the number to be supplied in each certain lot.

1.7.1 Request for warranty term

The guarantee period for the number plates shall be at least 5 (five) years while in case of a thermotransfer it shall be at least 2 (two) years.

In the price list the bidder shall reflect the manufacturer of the good and the country of origin.

2.2.1 Request related to the experience of a bidder

2.9.5 Amendment to the design and protective elemnets of the goods to be supplied shall be agreed with the buyer during the conclusion or/and during the contract on certain number of goods requested by the buyer without any additional expenses.

4.1.1 Request for document (s) confirming the adequavy of pricing

In case if the final price fixed in the system by e-tender winner bidder is less than the estimated value of the procurement subject by 20% or more, the buyer shall request the supplier to submit documents confirming the quequacy of pricing. The adequacy of pricing shall be confirmed by the contracty and/or invoice concluded by a bidder, which confirms the possibility of fulfilling the obligations undertaken by the contract for the price fixed by the bidder.

Terms of payment

The advance bank security shall be submitted in the currency requested by the supplier. The bank security shall be issued by the banking institution licensed by the National Bank of Georgia and/or the insurance company

licensed by the LEPL Insurance State Supervision Service of Georgia. The payment of the remaining amount shall be carried out after the deduction of the amount received as an advance

7.2 Conditions for Installment and/or Final Payment
