

AMENDMENT #6 of CONTRACT No: LMDC/CS/IC/11

Financial Management Consultant for Land Market Development Component

This contract Amendment #6 ("CONTRACT AMENDMENT #6") is entered into
March 01, 2019
between

LEPL National Agency of Public Registry of Georgia (NAPR), address: 2, Sanapiro strN2, 0102 Tbilisi, Georgia
(Hereinafter "the Client"), on the one part,
and
Ms. Tamar Avakimova (ID# 01009020874), address: app.11, building 32, II block, Vazha-Pshavela Ave, Tbilisi, Georgia (Hereinafter "the Consultant"), on the other part,

Considering decreased volume of work of the Financial Manager under the Irrigation and Land Market Development Project Land Market Development Component (ILMDP), it is necessary to extend the contract through July 31, 2019 with the following revisions:

The parties hereby agree to make changes as follows:

1. Clause 2 – "Term" to be changed as follows:

The Consultant shall perform the Services during the period commencing 25.03.2016 and continuing until 31.07.2019, or any other period as may be subsequently agreed by the parties in writing.

2. Clause 3 – "Payment" to be changed as follows:

A. Ceiling

For Services rendered pursuant to Annex A, the Client shall pay the Consultant an amount not to exceed **148,000.00 GEL (One Hundred Fourty Eight Thousand Georgian Lari)**. This amount has been established based on the understanding that it includes all of the Consultant's costs and profits as well as any tax obligation that may be imposed on the Consultant in accordance with the Georgian Legislation. Income Tax shall be paid in accordance with the Georgian Legislation. The payments made under the Contract consist of the Consultant's remuneration as defined in sub-paragraph B below.

3. Annex B – "Cost Estimate of Services, List of Personnel and Schedule of Rates" to be changed as follows:

The total contract cost including taxes – GEL 148,000.00, out of which GEL 29,600.00 is income tax.

- 5. The Contract Amendment No.6 is valid from the day of its signing.
