### AMENDMENT #7 of CONTRACT No: LMDC/CS/IC/11

# Financial Management Consultant for Land Market Development Component

This contract Amendment #7 ("CONTRACT AMENDMENT #7") is entered into July 31, 2019

between

(Hereinafter "the Client"), on the one part,

and

The Irrigation and Land Market Development Project (ILMDP) is still ongoing. Thus, it is necessary to extend Financial Management Consultant's (National Consultant) contract, i.e. until September 01, 2019.

#### The parties hereby agree to make changes as follows:

1. Clause 2 - "Term" to be changed as follows:

The Consultant shall perform the Services during the period commencing 25.03.2016 and continuing until 01.09.2019, or any other period as may be subsequently agreed by the parties in writing.

2. Clause 3 - "Payment" to be changed as follows:

A. Ceiling

For Services rendered pursuant to Annex A, the Client shall pay the Consultant an amount not to exceed **150,000.00 GEL (One Hundred Fifty Thousand Georgian Lari).** This amount has been established based on the understanding that it includes all of the Consultant's costs and profits as well as any tax obligation that may be imposed on the Consultant in accordance with the Georgian Legislation. Starting from March 01, 2019 the Consultant is responsible for taxation. The payments made under the Contract consist of the Consultant's remuneration as defined in sub-paragraph B below.
